## **Chair's Annual Report**



#### A reminder ...

Minety Community Shop Ltd is registered as a Community Benefit Society with the FCA; an organization that has been established with a social or environmental goal. It has a non-profit constitution and is run for the benefit of the wider community, reflecting commitment to that community, re-investing any profits made into the business and the community.

#### **Our Mission**

To run a community-owned shop which provides an essential service and serves as a focal point for the village, providing a range of fresh local produce and everyday essentials such as groceries, newspapers and off-licence sales.

In addition, the shop aims to be a social centre for the village during the day by offering refreshments and free internet access. Where appropriate we will support local enterprises and organisations.



#### 2024/25 Achievements (1)

- A robust trading performance (more on that in the Treasurer's report)
- Continued product range extensions and promotional activities, including the everpresent meal deal with our local sandwich provider, plus a variety of other promotions including pizza, beer and wine promotions and the introduction of Brinkworth Dairy products
- Replaced the display freezer and front door
- Donations made to a number of local Community organisations including the Malmesbury foodbank
- Regular Volunteer events
- Updates to various policies and procedures, and the Staff Handbook, building on the robust work completed during 2023/24
- Supported Duke of Edinburgh students, more than 5
- Made area safe in front of the storage container with patio and a fence



#### 2024/25 Achievements (2)

#### Fundraising & events, with improved forward planning

- July '24 pop-up shop at the Minety Music Festival
- July '24 ice-creams for children at the both school and pre-school
- December '24 Christmas Quiz Night, Raffle Draw & supported the Church's Christmas Tree festival
- Supported the Community Lunches
- Engaged with the 'younger' shoppers through a 'Guess the name' cuddly toy competitions at Christmas and Easter
- Sold tickets at the shop for various Community events and activities
- March '25 Murder mystery presented by Purton Amateur Dramatic Society



#### Goals for 2025/26

- The Committee's annual strategic planning meeting was held on 16 June, with two key areas of focus:
  - 1. How we maintain our focus on our core priorities
  - 2. Planning for the future of the Shop, recognising that the Village Hall would like to have their meeting room space back at some point



#### Goals for 2025/26 (1)

#### Our core priorities (as defined at last year's AGM)

- To continue to strengthen the value offered to the community by the shop through the products and services, promotions & events
- To continue fundraising, through donations and grants, to reinvest in developing and growing the shop's value to the community
- To grow the Volunteer base and the Shop Committee
- To strengthen and develop the connections and collaboration with key Village community groups and committees, Village Hall, MPFA, the School and the Parish Council



#### Goals for 2025/26 (2)

### Continuous development of the shop, improving the customer value proposition for customers

#### This includes:

Focus on the look and feel of the outside of the current shop

### Planning for the future of the Shop, recognising that the Village Hall would like to get their meeting-room space back

We believe we have **three** options:

- 1. Close the shop, which is OBVIOUSLY not our preferred plan!
- 2. Remain close to the current Village Hall location
- 3. Find a new location within the Village

Work has begun to explore options 2 & 3. We have developed some independent plans, but before progressing and spending money we want to discuss jointly with the key stakeholders Village Hall, MPFA and Parish Council.

## Treasurer's Annual Report



#### Purpose:

- 1. To present the accounts for the period ended **31 March 2025**

#### Headline results for the year 2025/5

	2025/5	2023/4	Difference
Sales	£193,206	£187,421	+3.0%
Gross Profit	£58,601	£57,181	+2.5%
Administrative expenses	£50,579	£47,502	+6.5%
Operating Profit	£8,022	£9,679	-17.0%
Total Profit	£9,649	£10,728	-10.0%
Funds in Bank and In Hand	£75,147	£63,949	+17.5%



#### Some detail behind the figures

- Electricity costs increased by £700 (+33%)
- Repairs to our refrigeration units were particularly high and increased our repairs bills for the year by £1600 (+ 133%)
- Our investment income increased by £600 (+5.5%)
- Sales from our pop-up shop at the Minety Music Festival were down due to the very bad weather.
- Footfall and average spend remained relatively static



### Footfall and average spend 2021-26

PERIOD	FOOTFALL	AVERAGE SPEND
April 2021 to March 2022	23,679	£6.92
April 2022 to March 2023	26,007 <b>+9.8%</b>	£6.93 <b>+0.1%</b>
April 2023 to March 2024	28,518 <b>+9.7%</b>	£7.14 <b>+3.0</b> %
April 2024 to March 2025	29,047 <b>+0.1%</b>	£7.19 <b>+0.6%</b>
April 2025 to March 2026 (Forecast)	31,080 <b>+7.0%</b>	£7.50 <b>+4.3%</b>



#### Looking ahead to 2025/26

- Sales have shown a remarkable upturn averaging 15% for the past 6 months. If continued for the whole year this is likely to increase operating profits from £9,649 last year to in excess of £14,000 for the coming year.
- The shop team are currently analysing sales patterns to try and identify any specific reasons for the increase and assess any implication this might have for marketing, stock holding or pricing.
- The change from Barclaycard to Dojo for card processing will reduce bank charges by £60-£70 per month.
- Investment rates are falling but interest income will continue to be significant

## Proposal to disapply the requirements for formal audit for the year 2025/6



"The Community Benefit Societies Act 2014 (amended 2018):

Societies may disapply the requirement to appoint a qualified auditor to audit the accounts provided:

- Assets are below £5.1 million
- Turnover is below £10.2 million
- A resolution is passed to "disapply the requirement for audit"

## Measures in place to assure the accounts



- Separation of financial duties
- Selective audit by the Treasurer
- Annual Budget prepared
- Monthly review by the Committee
- Mid-term review by the Finance sub-committee
- Completion of final accounts and tax calculations by a professional Accountancy firm who have remote access to the accounting system
- Ad-hoc benchmarking with other Community shops

## **Application of Profits**





Minety Community Shop Ltd is a Community Benefit Society. As such is it is a 'not for profit' organisation and any excess profits or funds can be used for the benefit for the community.

The Committee recognises that there is a primary responsibility to ensure the continuation of the Shop. In service of that objective:

- an annual target gross profit percentage is defined that ...
  - ... protects the shop in terms of forecasted costs, whilst providing contingency for unexpected costs plus savings for the future
  - ... protects the community from higher than necessary product pricing, thereby encouraging local shopping to continue
- any profits achieved over the target may be shared between the shop and other community purposes, recognising that those purposes may vary from year to year

## Proposal to review the Society's Rules



#### Review of Society's Rules

- As a Community Benefit Society (CBS) the shop is a member of the Plunkett Foundation
- Plunkett provides support and is an intermediary with the Financial Conduct Authority (FCA)
- It produces Model Rules for community ownership
- We were established under their 2017 Rules
- We now need to check our procedures against the new version, due Sept.
- If significant change needed, we need to consult members because it is YOUR SOCIETY!
